1 Have a goal. And review it annually.

Investment Policy Statement WealthChannel WorkSheet

Investment Goal

For example: "I'd like to grow my net worth from \$2M to \$10M so that I can live off of my passive income and retire early (before age 55)."

Investment Time Horizon

For example: "My investment time horizon is 20 years (before retirement), then I'd assume 30-40 years in retirement."

Have a goal. And review it annually.

Risk Tolerance

For example: "I have a relatively low risk tolerance. I want my portfolio to be far less volatile than the S&P."

Target Asset Allocation

For example: "50% stocks (majority domestic), 25% fixed income, 25% alternative investments."

Wrappers, Accounts & Tax Planning

For example: "I want to max out my 401k and IRA space with my least tax-efficient investments" (like bond funds); and I want to make sure my 25% allocation to alternatives includes a lot of tax-efficient investments, such as energy investments and Opportunity Zone funds. For my traditional investments (like stocks), I will use low-cost, efficient wrappers (mainly ETFs)."

1 Have a goal. And review it annually.

Portfolio Rebalancing Process

For example: "I will rebalance my portfolio every 5 years (at a minimum), or annually (at a maximum) if I believe conditions warrant it."

Portfolio & IPS Review Process

For example: "I will revisit my portfolio and IPS annually, every January."

2 Think triple-net returns.
